Information Collection and Use

General

- JaMar UK collects personal information when you register with JaMar UK, when you use Sign In, My bookings, My details, Make Reservation. Or view the pages from www.jamaruk.co.uk website
- When you register we ask for information such as your name, email address, birth date, gender, postal code, telephone and fax numbers address, Once you register with JaMar UK, and sign in to our services, you are not anonymous to us.
- JaMar UK collects information about your transactions with us and with some of our business partners, including PayPal Our dedicated online secure PayPal system & "HSBC our dedicated ePayments Merchant System"
- JaMar UK automatically receives and records information on our server logs from your browser, including your IP address, page views, and browser versions.
- JaMar UK uses information for the following general purposes: to customize the reservation and content you see, fulfil your requests for reservation, amendment services, improve our services, contact you,.
- JaMar UK does not give any personnel details, which are held on our servers, to third party sites or any of their representatives.

Employee and Contractor Access to Information

- JaMar UK limits access to personal information about you to those employees who we reasonably believe need to come into contact with that information to provide products or services to you or in order to do their jobs.

Security Steps We Have Taken

- **Secure Socket Layer (SSL)**
JaMar UK uses SSL (Secure Socket Layer) encryption when transmitting certain kinds of information, such as financial services information or payment information. An icon resembling a padlock is displayed on the bottom of most browser's window during SSL transactions that involve credit cards and other forms of payment. Any time JaMar UK asks you for a credit card number on www.jamaruk.co.uk for payment or for verification purposes, it will be SSL encrypted. The information you provide will be stored securely on our servers. Once you choose to store or enter your credit card number on JaMar UK or its Business Partners sites being PayPal & "HSBC our dedicated ePayments Merchant System", it will not be displayed back to you in its entirety when you retrieve or edit it in the future. Instead of the entire number, you will only see asterisks and either the first four digits or the last four digits of your number.

- JaMar UK may update this policy. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your JaMar UK account or by placing a prominent notice on our site.

Your Ability to Edit and Delete Your Account Information and Preferences

- You can edit your Personnel Details from within your own login section at anytime.
- To cancel your account with JaMar UK. A letter from the head account holder detailing the cancellation of the account must be addressed in writing. Please note we do not accept Telephone calls, E-mails, or faxes as confirmation of cancellation.
